Notes

(1) The Board of Trustees of Antwerp International School retains the right to update school fees if the target number of students is not met on 1 September of the current school year.

(2) Fees include most of the costs for class field trips and some of the costs for the IB programme. Tuition fees are payable 30 days after invoice date. 70% of the tuition fee is invoiced on 1 July 2024 and 30% on 1 December 2024.

(3) Students who leave early:

- For students who have paid the first 70% instalment of the fees and who leave between 1 July and 31 December 2024, there will be no refund.
- Students who have paid the tuition in full and leave between 1 July and 31 December 2024 will be reimbursed 30% of the fees.
- For students who have paid the tuition in full and leave between 1 January and 30 June 2025, there will be no refund.

Students who enrol late:

- Students who enrol between 1 September and 31 December 2024 will pay the fees in full.
- For students who enrol later than 31 December 2024, the fees for enrolment are:

- In January 2025	70% of annual fees
- In February 2025	60% of annual fees
- In March 2025	50% of annual fees
- In April 2025	40% of annual fees
- In May 2025	30% of annual fees
- In June 2025	20% of annual fees

(4) Taxi riders will be invoiced at the end of each month. When signing up for the taxi service you agree to pay for all school days, even when your child cannot use the service due to absence or sport activities.

(5) All parents are liable for fees on the due date whether or not companies assume all or part of the fees. A late payment charge of 1.5% per month of the outstanding amount shall be charged for each student if payment has not been made within 30 days of invoicing.
